# **Direct Legal Representation**

Last year, Lawyers Alliance represented approximately 700 nonprofits and social enterprises on 1,400 different legal matters. Our clients receive legal counsel on nonprofit, corporate, financing, real estate, tax, employment, intellectual property, information technology, and other business and transactional law issues that are critical to their operations.

# **FYE 2023 RESULTS**

Lawyers Alliance works with hundreds of organizations building a better New York and promoting justice and equity, including in five program priority areas: Community Arts, Economic Opportunity, Housing and Human Services, Quality Education, and Urban Health.

# **Business law and transactional services**

- 1,418 legal matters, among them:
  - > 717 organizational clients served
  - > 658 new matters
  - > 44% matters completed
  - > 97 new matters for 58 multiservice clients
  - > 70 new matters for 52 clients related to new and changing technologies
- 1,200+ Resource Calls, trainings, Legal Alerts, and pro bono clinics
- 2,200 legal volunteers

#### **Outcomes**

- One year after case completed, 94% of reporting clients had positive outcomes as a result of Lawyers Alliance services.\* Of these:
  - > 96% improved staff or Board operations
  - > 82% expanded or preserved programming
  - > 75% enhanced or stabilized financial performance

We are strongly committed to recognizing the stellar work of dedicated and talented volunteer attorneys and helping them to set a leadership example for other lawyers.










## **FINANCIAL PROFILE**

Connecting lawyers, nonprofits, and communities


Donations from law firms, foundations, banks, corporations, individuals, and special events enable Lawyers Alliance to help nonprofits build a better future for low-income New Yorkers.

For the fiscal year ending June 30, 2023, Lawyers Alliance for New York's new revenues were \$3,306,470. This includes \$478,848 in new restricted gifts to support Lawyers Alliance's future. The financial statements also reflect \$1,253,952 in net assets released from restrictions from previous contributions, which helped cover Lawyers Alliance FYE 2023 operating expenses.\* Lawyers Alliance's expenses in the fiscal year were \$4,032,861.
