Expert trusts and estates attorney helps nonprofits access important charitable bequests

Nonprofits are often the beneficiaries of gifts from generous donors' estates and need legal help navigating the process. Since 2017, Jerome L. Levine has leveraged his trusts and estates expertise to support Lawyers Alliance clients, serving as both primary counsel and supervising attorney. His counsel has left a significant impact on organizations such as **SAGE (Advocacy & Services for LGBTQ+ Elders)**, an organization dedicated to improving the lives of LGBTQ+ older adults, and **Children's Defense Fund–New York**, which champions policies and programs to improve the overall lives of America's children. Q. How and why did you first become involved with Lawyers Alliance?

Lawyers Alliance represents many small charities which need pro bono assistance in a broad range of different practice areas. It is unusual to find opportunities to represent pro bono clients on trust and estate matters which are similar to those I handle for regular clients. I responded to a posting for a charity which needed representation as the beneficiary of an estate which was languishing because the named executors refused to qualify.

Q. Share a tip for making time for pro bono.

Do not think of pro bono as something you do in your spare time. Integrate pro bono work into your regular practice. Each pro bono client is just as important as your paying clients.

Q. Share a fun or unexpected moment from pro bono work through Lawyers Alliance.

It was both unexpected and fun to find out the complexity of the estate situations which Lawyers Alliance referred to me. When I volunteered to work with SAGE, I expected to find situations I had considered before. It turned out in both cases that the representations presented unusual facts which required novel solutions. They gave us valuable learning experiences and the opportunity to fashion creative approaches for the client.

Q. What's the most rewarding aspect of pro bono work?

The gratitude of the pro bono clients and the recognition that those clients would have been denied favorable outcomes without my representation.
