I've met with a lot of talented people who serve in roles I would not have known existed without participating in Lawyers Alliance.

Q. What's the most rewarding aspect of pro bono work?

As noted above, I love the "learning" aspect of the process but I also take real joy in being able to "give back" through these organizations. Every client I have had through Lawyers Alliance has been dedicated to making their community a better place, so being even a small part of that process is rewarding.
