The Society, now a division of RUMC, has for more than a century provided mental health and related services to Staten Island children and adolescents (and their families) who are emotionally disturbed, developmentally delayed, neurologically impaired, dependent on drugs or alcohol, and/or economically disadvantaged.

Effecting a strategic merger between a multi-faceted community-based nonprofit and a nonprofit hospital system is a complicated project. In addition to the documentation of the merger transaction itself and the processes surrounding the specific corporate restructuring, there are other issues. Mr. Carter had to help the client negotiate transitional services and other revenue sharing agreements, tread a narrow path to regulatory and counterparty approvals, navigate due diligence, and harmonize the sometimes divergent understandings of the parties with respect to future operations.
