***Corporate lawyers dedicate profound expertise to solar electricity project in Brooklyn***

Matthew Ahrens, Richard Hillman, and Milbank colleagues helped **Fifth Avenue Committee** (FAC) structure and document the installation of solar electricity on FAC-owned multi-family affordable housing. The FAC portfolio of community shared solar projects makes solar accessible and affordable for tenants living multi-family buildings. FAC is a 40-year old nonprofit community development corporation in South Brooklyn that advances economic and social justice, serving 5,000 low- to moderate-income residents annually.

FAC is making solar affordable by combining smaller projects into one portfolio. All of the zero-cost solar electricity is then credited to FAC accounts. FAC Solar is making the solar cost savings and sustainability benefits currently enjoyed by single-family homeowners available to tenants in multi-family buildings.

Together with colleagues, Mr. Ahrens and Mr. Hillman have provided comprehensive legal advice on the project from its inception in 2017, including preliminary structuring considerations, regulatory aspects, initial due diligence with respect to third-party stakeholders, creation of the special purpose vehicle, and associated financing and design and construction contracts. This has enabled FAC to implement a project that is helping needy families save money and is contributing to citywide sustainability goals, with potential for replicability at scale by similar nonprofits.
