# Clear pro bono commitment, including complex transactional work, strengthens nonprofits

Milbank's strong community service ethic is reflected in its more than 25-year pro bono relationship with Lawyers Alliance. The firm expects all of its attorneys to

dedicate a minimum of 25 hours to pro bono work annually. In 2021, Milbank topped 57,000 pro bono hours globally and handled 700 active cases, with more than 95 percent of its U.S. lawyers taking on pro bono matters. As part of this work, Milbank attorneys worked on 50 different legal matters for 39 Lawyers Alliance clients in the past

five years, helping organizations to navigate leases, contracts, governance issues, and strategic alliances. This work has a positive impact on nonprofits serving low-income communities throughout and beyond New York City, and pro bono clients have consistently praised Milbank's attorneys for their assistance.

Among many exceptional examples, Milbank's real estate expertise, including the review and negotiation of complex leases, benefitted several City nonprofits, including **Forestdale**, a multiservice agency in Western Queens serving more than 13,500 multicultural residents who range in age from five to 95, and **BxArts Factory**, a community arts nonprofit that provides space and support to local artists working in the Bronx. Milbank corporate, tax, and structured finance attorneys drafted clearly written guidelines for community partners regarding the distribution of pandemic relief funds. Drafting a template grant agreement for the coronavirus emergency grants to community partners for **New York Immigration Coalition**, an umbrella policy and advocacy organization, had an exponential impact for more than 200 groups in New York State that work with immigrants and refugees.
