***Healthcare attorney guides community-based providers through regulatory changes***

Ari J. Markenson is a partner with the healthcare practice at Winston & Strawn LLP. He received a B.A. from Syracuse University in 1993, a J.D. from Brooklyn Law School in 1996, and an M.P.H. from Columbia University in 1998.
