The Community League of the Heights (CLOTH) is a multi-service community development organization dedicated to supporting and empowering the economically disadvantaged residents of Washington Heights. The organization was founded in 1952 to provide recreational and educational opportunities for the neighborhood's children and youth and has since expanded its focus to include community revitalization, business improvement, development and restoration of affordable housing, a community school, health services and nutrition, and workforce development.

Because CLOTH's employee manual was last updated in 2020, management sought pro bono legal assistance to review the policies to reflect external and internal changes. CLOTH has 20 full-time employees and 24 part-time employees and runs a wholly-owned subsidiary, Ready Workers Management Corp. Ready Workers is a business corporation that provides management services solely to CLOTH's housing developments and has 13 full-time employees. CLOTH applies many of the same employment policies to both entities and needed a single legal team to review both manuals.

Sam Ellison and William Sunkel of Winston & Strawn LLP met with representatives from CLOTH to learn about the organization and discuss how the manuals could strengthen its important work in the Washington Heights community. The volunteers updated both employee manuals to ensure compliance with applicable law and advised CLOTH with respect to recent developments in employment law.

Yvonne Stennett, Executive Director of Community League of the Heights, said, "Getting our employee manuals updated was extremely important to CLOTH. Sam and Bill's experience and expertise were invaluable during the entire process. They made sure that every aspect of the manuals was compliant with current federal, state, and city laws.
