Accomplishment: Helped Manhattan Youth Recreation and Resources provide quality programs to families by updating its fundamental corporate governance documents, including its Bylaws, Conflict of Interest Policy, and Whistleblower Policy in compliance with the New York Not-for-Profit Corporation Law, enabling it to better serve its community.

Specific Case Highlights: Manhattan Youth Recreation and Resources (Manhattan Youth), a 501(c)(3) nonprofit corporation, was formed in 1986 to help the Lower Manhattan community meet its childcare and recreation needs. Manhattan Youth offers extensive programs for families, including after-school programs; youth, adult, and senior community programs and education programs; summer camps; and sports programs. Manhattan Youth also runs the Lower Manhattan Family Fund, which assists working families by providing care for children whose parents are ill or disabled, and college application, preparation, and tuition assistance.

Due to Manhattan Youth's growth, the founder approached Lawyers Alliance for assistance in updating its governance policies and internal documentation to comply with all of the legal requirements governing nonprofits in New York. Manhattan Youth needed its Bylaws, Conflict of Interest Policy, and Whistleblower Policy updated as well as a consultation with respect to Guidelines for Board members.

Nathan Greene, a partner at **Shearman & Sterling LLP,** ably assisted Manhattan Youth with updating and revising the governance documents and the Board Guidelines to ensure compliance with the law and with best practices.
