**Accomplishment:** Guided the Crime Victims Treatment Center through a multi-step process to separate from its former hospital base, and created a New York Not-for-Profit Corporation, complete with federal and state tax exemptions, as well as new space and protections for its intellectual property.

**Specific Case Highlights:** Crime Victims Treatment Center (CVTC) has been helping survivors of interpersonal violence heal since 1977. CVTC respects that healing comes in many forms and recognizes the importance of a holistic approach. By working with hospitals, CVTC is available to assist survivors in the moments immediately following an assault with a wide range of therapeutic services completely free of charge. CVTC also advocates on behalf of survivors, collaborating with partners across a multitude of disciplines, and offers training for those who work with survivors.

Given a desire to expand the programs of CVTC beyond the existing hospital system, and a variety of other factors, in 2016 the governing body of CVTC thought it prudent to cease being a program of the hospital and instead create a new not-for-profit organization to carry on and expand the reach of the CVTC.

The Kirkland team, ably led by Richard Aftanas, assisted with drafting and negotiating a separating agreement and incorporating as a nonprofit organization (including drafting bylaws and a conflict of interest policy, and filing for tax exempt status at the federal, state, and local level). The process also involved complex issues relating to the existing union, the custody of medical records, and asset transfers. In 2018, CVTC leased new space in downtown Manhattan and is expanding its staff and services to now include a sexual assault prevention program. It also received a grant to start a legal services program. CVTC is proud to report that its substantial growth is actively expanding into some of the most underserved communities in New York City.
