Staff Attorney Position

We seek a Staff Attorney with corporate law and transactional experience to join our well-respected team. This Staff Attorney also will work with other staff and pro bono attorneys to bring a wide range of high quality legal services and practical information to other nonprofit organizations benefiting the well-being of New Yorkers.

Responsibilities

- Plan and execute systematic and strategic client outreach to expand legal services to new and
 existing clients dealing with the immediate and long-term effects of the pandemic and economic
 uncertainty.
- Advise and assist human services, community development and other nonprofit organizations
 with timely business law and transactional needs, including governance, contracts, borrowing,
 fundraising, earned revenues, strategic alliances, mergers, collaborations, restructuring,
 dissolutions, and regulatory compliance.
- Engage in effective client intake and screening to ready groups for legal help, with focus on those engaged in pandemic and economic recovery.
- Provide support, mentoring, and co-counseling assistance to pro bono attorneys from top law firms and corporate legal departments and assist with volunteer recruitment and recognition.

- Organize and teach workshops, write legal alerts and publications, and represent Lawyers Alliance at pro bono clinics and other events for clients and pro bono attorneys.
- Collaborate with staff colleagues on quality control, program evaluation, outcomes measurement, strategic planning, and technical assistance grants and contracts.
- Support marketing, fundraising, fee-generation, tracking and use of data, special projects and other duties as requested.

Experience and Attributes

- Admission to the New York State Bar.
- At least five years of legal experience handling corporate finance, tax or other business-related transactions, preferably in a major law firm.
- Track record of increasing responsibility in contract negotiations, financing, loan documents, mergers, and/or bankruptcy and workouts, along with helpful client counseling.
- Clear and effective communicator, excellent writing and speaking skills, and an ability to work independently and be an effective mentor to staff and volunteers.
- Initiative and business development skills.
- Keen interest in New York City and its diverse and varied neighborhoods.
- Relevant skills from representing or volunteering with tax exempt corporations are a plus.
